

**“MACQUARIE CENTRE SPEND AND GET DINING”  
TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is Macquarie Centre (ABN. 13 001 595 955), managed by AMP Capital Shopping Centres, Cnr. Herring and Waterloo Rds. Phone: 02 9887 0800 (“**Promoter**”).
3. Entry is only open to Australian residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.
4. Employees (and their immediate families) of the Promoter, tenants and their employees of the promoter and agencies associated with this promotion are ineligible to enter.   - b) complete the online form and present the confirmation email and valid original tax invoice receipt(s) totalling at least \$50.00 (specifying the store and dates of purchase) to the Concierge Desk on Level 3 during Centre trading hours.
  - c) customers will receive an SMS within 1-2 business days with a link to access their \$10 The Restaurant Gift Card by downloading the TCN App and adding the digital card to their mobile wallet. The Restaurant Card can be used at participating restaurants and cafes that accept contactless payment at Macquarie Centre. Fast food outlets are not included as participating locations. 8. Fresh Food, Supermarkets and Liquor Stores are excluded from this promotion.
9. Incomplete, indecipherable, or illegible entries will be deemed invalid.
10. No responsibility will be taken by Macquarie Centre for non-acceptance of the Gift.
11. Only one (1) \$10 The Restaurant Gift Card Dining is permitted per \$50 spend, per person, per day.
12. Entrants must retain original tax invoice receipt(s) as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an entrant’s entries and forfeiture of any right to a prize. Purchase receipt(s) must clearly specify the store of purchase and that the purchase was made during the Promotional Period but prior to entry.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) taking/use of a prize.
