

**“MACQUARIE CENTRE LUNCH PERKS” PROMOTION**  
**TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is Macquarie Centre (ABN. 13 001 595 955), managed by AMP Capital Shopping Centres, Cnr. Herring and Waterloo Rds. Phone: 02 9887 0800 (“**Promoter**”).
3. Entry is only open to Australian residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.
4. Employees (and their immediate families) of the Promoter, tenants and their employees of the promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
5. This promotion will be conducted at the food court in the Macquarie Centre in Corner Herring and Waterloo Rds North Ryde, NSW (“**Centre**”).
6. Promotion commences on **Tuesday 23 March 2021** and ends at **5:59pm on Wednesday 30 June 2021** or while loyalty cards last (“**Promotional Period**”).
7. To be eligible to participate in this promotion and receive \$5 off and \$10 off on meals with participating food court retailers, individuals must complete the following steps during the Promotional Period:
  - a) Customers must spend \$10.00 in one meal at any of the [participating food court retailers](#) at Macquarie Centre and receive an approved stamp on the relevant meal number
  - b) Submit the loyalty card to a participating food court retailer after the 5<sup>th</sup> and 10<sup>th</sup> meals respectively (with the correct number of verified stamps) to redeem the \$5 off and \$10 off discount on a purchase greater than or equal to \$10.00.
8. Inauthentic, indecipherable, or illegible entries will be deemed invalid.
9. Only one (1) loyalty card is permitted per person and one (1) redemption of the \$5 off offer and \$10 off offer.
10. Fresh Food, Dine-in restaurants, Supermarkets and Liquor Stores are excluded from this promotion.
11. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
12. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
13. The Promoter’s decision is final and no correspondence will be entered into.
14. If any prize (or part of any prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.

15. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
16. Any cost associated with accessing the promotional website is the entrant's responsibility and is dependent on the Internet service provider used.
17. The total offer value is \$9,000 (600x \$5 off redemptions) and (600x \$10 off redemptions). Any unused portion of the \$5 off or \$10 off are not transferable to exchangeable as cash, at any other venue outside of those participating retailers.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) taking/use of a prize.
