

# Terms and Conditions

## Dine & Receive Promotion

1. Information on how to claim your Entertainment Passes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Excluded from the promotion:
  - i. employees of Macquarie Centre, AMP Capital Shopping Centres Pty Limited, AMP, and their immediate family;
  - ii. tenants in the shopping centre and their immediate family;
  - iii. the staff of tenants in the shopping centre and their immediate family;
  - iv. the proprietors and staff of companies involved in the production, publishing and administration of this promotion and their immediate family; and
